His Climb to the Summit

It was once said that in hospitality, the chief thing is the good will. Enter Brother Bill Jones III, President George W. Bush, and the leaders of Canada, France, Germany, Italy, Japan, Russia, the United Kingdom and the European Union.

It all began in the fall of 2002. Jones was on a hunting excursion in Cabin Bluff, Ga., with his cousin, Congressman Rob Portman (Ohio 2nd Congressional District), and Joe Hagin, assistant to the president

and White House Deputy Chief of Staff. The outcome of this

After having worked for several resorts following graduation, Jones filled several management capacities at Sea Island, including national sales manager and executive vice president. In 1992, he was elected to succeed his father as president, and in 1995, he became CEO. Finally, in 1997, Jones became the chairman of the board.

With so many opportunities for the "white glove" treatment, it is no wonder that Sea Island is where President George H.W. Bush and new wife, Barbara, chose to honeymoon in 1945. Avid golf fans may remember Sea Island as the 2001 host of the Walker Cup and a two-time home to the UBS Cup.

As a traditional vacationing spot and the home of an occasional rush party, Sea Island has accommodated several Gamma alumni and active brothers. Known as one of the finest resorts in the world, its Lodge at Sea Island is a year-to-year the recipient of AAA's Five-Diamond Award and the Mobil Five-Star Hotel Award. While enjoying a relaxing getaway with Congressman Portman and Deputy Chief of Staff Hagin, Jones voiced his interest in someday hosting some kind of international leadership retreat. One of them suggested that since 2004 was the year the United States was slated to host the G8 Summit, maybe Sea Island could host this annual meeting of the leaders of the world's major industrial democracies.

In June 2003, the decision by the White House was confirmed: Sea Island would host the 30th G8 Summit. Preparations soon began, including room modifications for a guest list that filled the resort during the summit, June 8-10, 2004.

And the summit was an obvious success. President Bush and British Prime Minister Tony Blair experienced a complete Sea Island experience by each planting an oak tree on the grounds of the resort, a tradition that was started at the very beginning ... by President Calvin Coolidge.

"Laura and I thank the citizens of this part of our country," President Bush announced in a press conference following the summit. "This was a successful summit because the people here made it successful by being so warm and gracious. The Southern hospitality was strong. The citizens of Sea Island, and Brunswick and Savannah, as well as people from around Georgia, were just really great, and we thank them. All the leaders with whom we talked asked me to express my appreciation to the people of this part of the world."

When asked what is next for Jones, he said, "There are many different things in the future. But I am just having a great time." Add to his summit credits the honor of being named Georgia Trend Magazine's Georgian of the Year for 2004 and 2003 Entrepreneur of the Year for the Georgia-Alabama-Tennessee area by Ernst & Young, and many are left wondering what could possibly be next.

In addition to his Sea Island enterprises, Jones recently completed his term as chairman of the Georgia Research Alliance Trustees and is a member of Gov. Sonny Perdue's Commission for a New Georgia and a director for the Georgia Chamber of Commerce, King & Prince Seafood Corporation, Synovus Financial Corporation and Total Systems Services. Inc. Additionally, he is a trustee for The Nature Conservancy of Georgia and the Epworth-by-the-Sea Methodist Center. Jones and wife, Sally Hopper, a UGA graduate, reside on St. Simons Island, Ga.
